EURO Working Groups

F For smaller groups of researchers interested in a specific OR topic EURO provides an organizational framework in the form of EURO Working Groups (EWGs). These groups are a very important part of EURO. They represent in its best form continuity in research in EURO's activities. Active EWGs have a meeting at least once a year where the members exchange ideas, experiences and research results and support each

other in the research work. Cooperation continuing for several years, even decades has also strengthened personal relations of the group members making the atmosphere in the group open and friendly. In addition to their annual meetings the groups have also other ways of working; for example they organize sessions in conferences, publish special issues of the European Journal of Operational Research or other OR-related journals and organize conferences. In the coming EURO XIV conference in Israel the audience will have an excellent opportunity to get acquainted with areas of interest of the EWGs and the past, presence and future of the respective research fields. In addition to the large number of presentations by individual members of the groups there will be semi-plenary presentation on each topic.

During 20 years that EURO has existed there has also been EURO Working Groups. Four of the groups founded in

1975 are still active. Some of the groups founded over the years have faded away, but new ones have also come into existence. The family of EWGs grew with two members in January this year when the Executive Committee of EURO gave the EURO label to two groups: "European Group Decision and Negotiation Support Working Group" and "MODEST - Modelling of Economies and Societies in Transition". More information on these EWGs can be found on the following pages. People who want to join a group or get more information about it are advised to contact either the coordinator of the group or the second vice-president of EURO.

What is required of a group that wants to become a EURO Working Group? First of all a group of people interested in cooperation on a specific topic of OR or in a field of OR applications is needed. In order to have an international, diversified EURO Working Group the group also has to meet the following principles:

1. The EWGs should as far as possible bring together people with different professional backgrounds (industry, university, etc.).
2. The group should be interna-

tional. This requirement is met if at least 4, but possibly 5 or 6 nations are represented at each meeting and if the meetings do not take place too often in the same country.

3. Any group should be open to any individual member of any EURO member society. In some exceptional case also persons that are not members of a national OR society can be accepted. The applications are taken up by EURO Executive Committee who decides whether the criteria above have been met and whether the group can be granted the EURO Working Group status.

Becoming a EURO Working Group brings duties and advantages to the group. One of the duties is that the EWGs have to report yearly on their activities to EURO. One of the advantages is that group obtains financial support from EURO. Financial support can be granted e.g. for printing costs of common stationery, for administrative costs in the establishment of a new EWG and occasionally for meeting expenses, such as those of guest speakers or for some specific colloquium or seminar. The Council of EURO has also given grants to support the participation of group members who are coming from Eastern or Southeast Europe or Eastern Central Europe and

who are presenting a paper in a group meeting. Another advantage is that EURO K can provide time and space for the meetings of the EWGs and the meetings can be set within the framework of the conference itself. Nowadays several EWGs organize their meetings on the day(s) before a EURO K conference starts, or on the day after it finishes. EURO also supports EWGs by offering an opportunity to use the EURO Bulletin as the group's newsletter.

More details on the organization and activities of EWGs are stated in the charter of the EURO Working Groups.

PURPOSE AND HISTORY: Multicriteria decision aid is an important branch of Operational Research. Beyond the exchanges and meetings which already exist by means of the international conferences and the publications in the scientific journals, the objectives of the working group are the following:

- to contribute to develop an original way of thinking, at a European level, in the field of multicriteria aid for decisions;
- to allow each member of the group to present his research, submit those to the critical discussion of the group, to present open problems;
- to keep a continuity in the exchanges and the work from one meeting to another;
- to keep the climate of a working group and not to transform the meeting in a small congress.

The working group was created at EURO I (Brussels, 1975). Since that time, two meetings are held each year, in Spring and Autumn. The 40 meetings have been or-

ganized by 14 different countries.

NUMBER OF MEMBERS: 283. In 1975, the group consisted of 29 members divided into 5 different countries. Among the present members, 42 were already members in 1980. At this period, 23 countries were represented. During these last years, each meeting induces 5 to 20 new members (with an average of 13). These figures show how the group is alive, to the biological sense of the term.

PURPOSE AND HISTORY: This working group was formed at the EURO I Congress in Brussels in 1975. The initiator and first chairman of the group was Prof. H. Zimmermann of RTWH, Aachen, Germany. The organization of the group, the forms its activities have taken, and the vitality and activity of the group are to a great extent due to his efforts.

The second chairman, Prof. Christer Carlsson of Åbo Akademi University, Finland, was acting since 1979 until 1986.

During the First IFSA (International Fuzzy Systems Association) Congress in Mallorca on July, 1-6, 1985, with due permission of the EURO Council the working group constituted itself as the European chapter of IFSA. Prof. Carlsson was elected as the first president of the European Chapter, with Prof. M. Roubens the president-elect, Prof. P. Smets treasurer, Prof. U. Hohle secretary and Dr. D. Dubois and A. Straszak members at large. Prof. Roubens served as the president from 1986 until 1993.

The purpose of the IFSA-EC is to communicate and to promote knowledge of the theory of Fuzzy Sets and related areas and their applications.

In order to realize the objectives the IFSA-EC publishes Newsletters and Bulletins, organizes workshops and symposia, establishes sub-chapters and sponsors such other activities consistent with the objectives as may be directed by the Board.

PURPOSE AND HISTORY: The decision to

set up the Health Working Group was taken at EURO I, Brussels, January 1975, making this group one of the first WGs established by EURO. The first meeting of the group took place in September 1975 in Exeter, UK and meetings have been taking place in different European countries every summer since then.

The aims of the group were restated at our 1991 meeting to be:

1. To improve co-operation and communication, and to encourage and support inspiration by group members.
2. To enable and support inter-disciplinary work on European health care issues.
3. To examine European health care systems using rational and systematic methods.
4. To encourage bilateral contacts between members throughout each year.

The title of the group "Operational Research Applied to Health Services" reflects the premise that the major challenge for OR scientists currently working in the health field lies not in developing new and/or more sophisticated techniques, but in using what expertise they currently possess to make more of an impact on the delivery of healthcare.

The idea is to provide a professional network, where the emphasis is on the exchange of professional knowledge by establishing social relations. To achieve this end, the size of the group is kept relatively

small, continuity of the group is regarded as highly valuable and the social programme of the meetings plays an important part.

NUMBER OF MEMBERS: 112 members are now on the register from 22 countries (mostly European).

NEWSLETTER: No newsletter in 1994, one newsletter in 1995.

ACTIVITIES 1994: The 20th Annual meeting of the WG took place in Chania, Crete during July 31st to August 5th, 1994. The theme of the meeting was Decision Support, and twenty five members from twelve countries attended and presented papers. It was felt to be a successful and enjoyable meeting, and our hosts, the Technical University of Crete, were warmly thanked for their support of the meeting. It is hoped that some of the papers presented will appear in a Feature Issue of EJOR.

PURPOSE AND HISTORY: The European Working Group on EUROBANKING, Operational Research in Banking, was set up in Brussels in January 1975 at the EURO I Conference sponsored by the International Federation of Operational Research Societies.

The purpose of the group is for OR practitioners to exchange and stimulate ideas about the techniques, experience, philosophy and application of operational research in banking. A secondary objective is to project operational research to bank management.

The group has members from virtually all Western European countries and the total membership is over one hundred. PURPOSE AND HISTORY: The decision to set up a Working Group on the field of Locational Analysis has been taken during the First EURO Summer Institute (Brussels, July 1984) in order to provide a network of people working together and to keep a continuity in the exchanges. So, the major goal of the WG is to stimulate the exchange of information and research; continuity of the group is regarded to be of main importance, and friendship among members plays an important role. The group holds yearly meetings organized by one of its members. It must be pointed out that the WG is not exclusive. Any changes to this list such as new members wishing to be on the list, changes in e-mail address and (not too quick) cancellation of membership in the list should be sent to *ewgla-admin@upf.es*. These messages will be handled and acted upon separately and not distributed. I hope this new instrument of our group will enhance the already quite intensive cooperation between EWGLA members. At the same time I hope this will stimulate those members who are not yet familiar with the fantastic communication medium of e-mail, to start using it. The main idea is that we remain in regular contact about current research in and news related to our field. Nothing is more stimulating than (almost) direct and instant contact with fellow researchers. Let us know for example that a working paper has been written and where it is available, that some paper was (finally) published (along with the full reference, please). Call for help or ideas on a particular topic when you start up or are consulted on something new. If you have obtained some relevant information that is potentially of interest to the other members, let them know. At the other hand do not overload your fellow researchers with bulk. This seems to be the main problem of wider networks as the Internet. Receiving daily huge quantities of totally uninteresting material is discouraging, and quickly leads to cancellation by many members. Also do not use this forum for personal messages :

send these directly to the person(s) involved.

Normal communications are not accepted in the ESIGMA meetings, for they can be presented in Congresses or in the meetings of the "Multicriteria Aid for Decision" Working Group. The programme of an ESIGMA meeting integrates both "Tutorial Sessions" and "Oriented Discussion Sessions". In Tutorial Sessions, invited prominent researchers are invited to present their research and methodologies, followed by discussion. On other hand, Oriented Discussion Sessions are devoted to the discussion of specific subjects, oriented by one or two members of the group.

PURPOSE AND HISTORY: The EURO Working Group on Project Management and Scheduling has been established by Prof. L. Tavares and J. Weglarz during the EURO VIII conference, Lisbon, September 1986. It was decided to organize a workshop every two years.

Gathering most promising theoretical and applied advances in Project Management and Scheduling to assess the state of the art of this field and its potential to support Management systems is the objective of these workshops.

The first workshop was held in Lisbon in July 1988, organized by L. Tavares. It gathered sixty participants from 16 countries. A special issue on Project Management and Scheduling was published by EJOR including selected papers from this Workshop (November, 1990). The second workshop was organized by J. PURPOSE AND HISTORY: The EURO Working Group on Financial Modelling was founded in September 1986 in Lisbon. The primary field of interest for the working group can be described as "financial models that help to solve problems faced by

financial managers in the firm". From this the following objectives of the working group are distinguished:

- providing an international forum for exchange of information and experience on financial modelling;
- encouraging research in financial modelling (new techniques, methodologies, empirical studies, software, etc.);
- stimulating and strengthening the interaction between financial economic theory and the practice of financial decision making;
- cooperating and exchanging information with other universities and financial institutions throughout Europe.

The meetings of the Working Group are organized twice a year, in April and in November. Earlier meetings were held in Belgium, Curaçao, Cyprus, Finland, Italy, the Netherlands, United Kingdom, Germany and Hungary. The meetings are attended by 80-100 members on average, most of them scientists but also representatives from the financial institutions, and are usually organized on Thursday, Friday and Saturday morning. The organizers are expected to schedule three types of sessions: a round table session with invited speaker(s), regular sessions with the presentation of refereed papers and balloon sessions in which unrefereed papers, new topics and "loose" ideas can be discussed.

This was particularly the case during the discussions as it was felt that a large proportion of the research findings and resultant literature was either published in North American journals (thus taking it away from its European perspective and enforcing a particular style) or in the language of the researcher's own country (making it difficult for others to access). Consequently identifying other researchers within Europe working on similar issues was problematic.

Over the two years that the working group has been in existence, it has sought to bring together people with different backgrounds (both in terms of disciplines and professions) and different countries. We currently have members from France, Italy, Belgium, The Netherlands, Germany, Finland, Sweden, Norway and Great Britain and hope to extend this. To further this diversity we have tried to ensure that the Seminar/Workshops are held in different countries (so far France, Norway, Scotland and Belgium) with the only exception being that the 4th and 5th Seminar/Workshops were both held in Glasgow, Scotland. This was in order to capitalise on the opportunity of linking the Working Group with the Euro XIII/OR 36 conference which was held in Glasgow 1994. This link resulted in a dedicated stream containing 15 papers and a joint event with the MCDM Working Group. In January 1995 the Group was granted the Working Group status within

EURO.

The aims and objectives of the Group are:

- to share experiences, knowledge and research outcomes in the area of Group Decision, and Negotiation Support

PURPOSE AND HISTORY: MODEST groups the specialists in mathematical and computer modelling who are especially interested in problems of modelling of the economic and social transformation processes taking place in modern world, with explicit emphasis on these processes which occur in the Central and Eastern parts of Europe. It is the purpose of the Working Group to establish a forum for exchange of ideas and experiences with that respect, but also to identify these areas where the most acute gaps exist and where modelling is feasible, and to formulate as well as to promote research projects for exactly these areas. The modelling that MODEST is most interested in is the pragmatic one (whether macro- or micro-economic, simple regression or complex dynamic, analytic or simulation, but oriented at definite current questions and based upon real data

or real-life guesses), though theoretical (e.g. economic political) models are not excluded from the MODEST's perspective.

The Working Group was established in the Spring of 1994 as an entirely informal body. By the Summer 1994 it reached the critical mass in terms of international and interdisciplinary character of the core membership. It is envisaged that the first MODEST workshop will also serve to increase importantly the Group's membership, though we do not aim at a large discipline-based membership.

In Fall 1994 the Group was granted affiliation with the Technical Committee of the International Federation of Automatic Control dealing with "Dynamic Modelling of National and Regional Economies" and, following this, it was proposed that Professor Zbigniew Nahorski might serve as the Vice-Chair of this Technical Committee. In January 1995 MODEST was granted, to our great satisfaction, the Working Group status within EURO. These two affiliations allow the Group to maintain the connection with two international communities which are essential for the methodology and implementation of modelling approaches and projects. The contacts with the two organizations are meant to be harmonized in accordance with their respective regulations and competence domains.
