Call for Applications for the EURO Doctoral Dissertation Award 2019



website

1. The EDDA 2019 jury will only consider dissertations in Operational Research defended between 1 February 2018 and 31 January 2019. The dissertation must have been defended in a University located in a **member country of EURO**. The author of the dissertation must be a member of a member society of EURO.

2. To be considered, a dissertation should be nominated by the supervisor of the thesis (one of them in case of multiple supervisors). The supervisor of the dissertation is asked to provide the jury with the following information:

1. The text of the dissertation;
2. An extended abstract (3 to 5 pages) of the dissertation; this abstract should be written in English and should include precise keywords;
3. An itemization of the candidate's contribution to each co-authored article if the dissertation contains co-authored articles (i.e., published papers or unpublished manuscripts);
4. If the dissertation is not in English, a paper in English which has been authored or co-authored by the candidate and which describes the core ideas of the dissertation. This paper should preferably have been published in or submitted to an international journal;
5. Nomination letters (or reports) from two referees selected by the dissertation supervisor, supporting the submission and stating their assessment of why the dissertation should win the award;
6. An up-to-date CV of the candidate, including a list of publications.

No nomination will be considered without these items. Please also check the **guidelines**.

Since many doctoral dissertations in OR are defended each year only outstanding pieces of work are expected to be submitted. The jury would like to remind supervisors that only high-quality theses might have a chance of winning the award.

3. The jury selects a short-list of finalists who will present their work in a special session at the 30th European Conference on Operational Research in Dublin. There is no registration fee for each finalist. EURO will also contribute to the travel and accommodation expenses. The winner will be determined by the jury at the end of the special session and will be announced by the chair of the jury during the closing session of the EURO 2019 Conference.

Call for Applications for the EURO Excellence in Practice Award 2019

1. All interested authors are invited to submit a detailed description of an application of OR with a real impact on practice, which has original features, whether in methodology, field of application and/or implementation. This may be in the form of a paper written for publication (although not necessarily published at the time of submission), a client report, or other appropriate documentation. The documentation must describe the work in a way that illustrates how it meets the criteria outlined below. The age limit for published papers is four years. The work must not have been submitted concurrently to another competition. The application is open to OR specialists from any part of the world. Please also check the **guidelines**.

2. The criteria for the evaluation of the papers are:

- real impact on practice,
- scientific quality,
- relevance to Operational Research,
- appreciation by the organisation involved with the application,
- originality in methodology, implementations and/or field of application.

Letters of appreciation are important.

3. The jury selects a short-list of finalists who will present their work in a special session at the 30th European Conference on Operational Research in Dublin. There is no registration fee for one author of each of the finalist presentations. The winner will be determined by the jury at the end of the special session and will be announced by the chair of the jury during the closing session of the EURO 2019 Conference.

Motivation

Environmental decisions can strongly impact nature, individuals, and society. Our society is urgently asked to find solutions for the sustainable use of resources and to carefully consider the long-term consequences of its actions, but these environmental policy decisions are difficult to make. Environmental systems can be ill-defined, may concern a range of stakeholders with opposed interests, and operate at different time scales. The multiple impacts of environmental decisions may be difficult to quantify and may result in significant societal burdens. Moreover, most environmental decisions are characterized by high uncertainty.

Methods from different fields are well suited to aid individual decision-makers as well as communities. These fields are diverse and include decision, risk, and policy analysis, operational research, economics, psychology, and the natural and engineering sciences. However, applying a single disciplinary perspective is clearly insufficient, and thus interdisciplinary approaches and multiple tiers of analysis are required.

The goal of this Feature Issue is to collect a wide range of papers that focus on the process of environmental decision-making. We are soliciting papers that show how to include different perspectives, stakeholders, and the public in the entire decision-making process. This ranges from framing the problem, eliciting preferences, spatial aspects of environmental decisions, and system modeling to communicating and implementing strategy. Insights into behavioral phenomena and biases, dealing with uncertainty, modeler-stakeholder interactions, or communication are welcome, particularly if they take a system perspective.

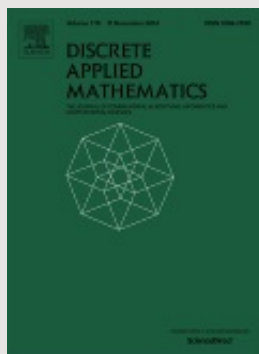

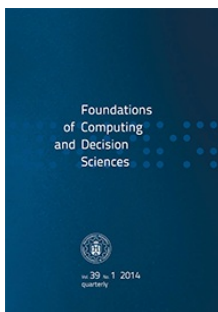

Depending on the number and quality of the applications the jury may decide to award two separate winners for 2017 and 2018.

To be considered, a dissertation should be nominated by the supervisor of the thesis (one of them in case of multiple supervisors). The supervisor of the dissertation is asked to provide the jury with the following information:

1. the text of the dissertation,
2. an extended abstract (up to 5 pages) of the dissertation; this abstract should be written in English,
3. if the dissertation is not written in English, a paper in English authored (or co-authored) by the author of the dissertation and describing the core ideas of the thesis. This paper should preferably have been published in or submitted to an international journal.
4. nomination letters (or reports) from two referees selected by the dissertation supervisor, supporting the submission and stating their assessment of why the thesis should win the award.
5. an up-to-date CV of the candidate, including a list of publications. No nomination will be considered without these items. All information should be sent in electronic form to the chairman of the jury, Wout Dullaert using a compressed format (e.g. zip).

Since many PhD theses in OR are defended each year, the jury would like to remind supervisors that only outstanding pieces of work have a reasonable chance of winning the award.

- Applications and/or potential applicability of the results,
- Impact on related fields,
- Quality of the related publications.

The jury may decide not to assign the prize if no thesis reaches an adequate level of quality.
